# READ ALL INSTRUCTIONS BEFORE YOU CALL THE COURT

This letter is provided to you to assist in the handling of the charge(s) filed against you. READ all instructions carefully and completely.

PLEASE NOTE: The Judge cannot discuss the merits of a pending judicial proceeding prior to actual trial (Canon 6(c) Code of Judicial Conduct). This means that the Judge is forbidden from discussing your citation with you before trial except as a procedural matter. If you plead GUILTY or NO CONTEST and have extenuating circumstances, the Judge can discuss them with you. A JUVENILE who fails to appear by the date and time on a citation may have his/her driver's license suspended as established by the Transportation Code 729.001.

FAILURE TO RESPOND IN A TIMELY MANNER CAN RESULT IN AN ARREST WARRANT BEING ISSUED FOR YOU! AFTER THE APPEARANCE DATE PASSES AND YOU HAVE FAILED TO APPEAR IN COURT: 1) YOU WILL BE CHARGED WITH THE ADDITIONAL CRIMINAL VIOLATION OF VIOLATE PROMISE TO APPEAR/FAILURE TO APPEAR, FOR WHICH ADDITIONAL FINES AND COSTS ARE ATTACHED; 2) AN ARREST WARRANT WILL BE ISSUED BY THE COURT; AND 3) THE RENEWAL OF YOUR DRIVER'S LICENSE MAY BE DENIED.

#### **OPTION 2: YOU MAY ASK FOR A TRIAL**

<u>Hand deliver or mail the following to the Mailing address above</u> <u>BEFORE the appearance date on the Citation:</u>

- 1) Check **4** NOT GUILTY on the plea form below. Give full VALID address information and valid phone number on plea form. Sign your name. Print your name. You will be notified of your Trial Date via mail.
- 2) Check your "request for trial by" selection of JUDGE or JURY.
- 3) A copy of the Citation
- 4) A copy of your VALID Texas Driver's License
- \*PLEASE NOTE: The fine schedule on this letter does not apply if you are found Guilty.

#### **OPTION 3: YOU MAY TAKE A DRIVING SAFETY COURSE**

(CDL license holders are NOT ELIGIBLE) To be eligible, you must not have taken the course in the past 12 months for the purpose of ticket dismissal and, you must not have been cited for speeding 25mph or more over the posted limit.

<u>Hand deliver or mail the following to the Mailing address above BEFORE</u> the appearance date on the Citation:

- 1) Check **3** GUILTY or NO CONTEST requesting DRIVING SAFETY COURSE on the plea form below. Give full address information and valid phone number on plea form. Sign your name. Print your name.
- 2) A copy of the Citation
- 3) A copy of your VALID Texas Driver's License
- 4) A copy of your VALID Proof of Liability Insurance. The Defendant's name must be listed on the proof.
- 5) A Self-Addressed, Stamped #10 Business envelope.
- 6) A payment of \$109.10. (MONEY ORDER OR CASHIER'S CHECK only. **NO PERSONAL CHECKS**)

You will have 90 days from the date of Court approval to complete a TEXAS approved DSC course and return the Certificate of Completion and other required documents to the Court. If you fail to meet the deadline, a warrant for your arrest may be issued.

\*If you apply and do not meet eligibility requirements, you forfeit \$10 Administration Fee and your entire fine amount will be due.

**OPTION 4: YOU MAY REQUEST DEFERRED DISPOSITION (Call the Court)**

TRAFFIC FINES ARE DOUBLED IN CONSTRUCTION ZONES WHEN WORKERS ARE PRESENT. IN CONSTRUCTION ZONES, A DRIVING SAFETY COURSE OR DEFERRED DISPOSITION IS **NOT** AN OPTION.

MOVING VIOLATION DISMISSAL: "You may be able to require that this charge be dismissed by taking a Driving Safety Course. However, you will lose the right if you do not provide written notice to the Court on or before your appearance date of your desire to do so." – Transportation Code 543.101

EXPIRED REGISTRATION OR OPERATE UNREGISTERED MOTOR VEHICLE VIOLATION DISMISSAL: Violation must be remedied within 20 business days. You must provide a copy of your State Registration receipt stating that PENALTY has been paid to the tax office along with a \$20 administration fee to the Court.

<u>DRIVER'S LICENSE DISMISSAL</u>: Must be renewed or corrected within 10 business days. You must provide a copy of renewal/correction along with a \$20 administration fee to the Court.

NO LIABILITY INSURANCE (FMFR) DISMISSAL: Charges will be dismissed upon presentation of valid insurance coverage to the Court, provided the coverage was valid at the time the citation was issued and presented on or before the appearance date.

Agent's name and phone number must be presented.

IF YOU FEEL YOU HAVE A LEGITAMATE INABILITY TO PAY, PLEASE CONTACT THE COURT.

The Court only accepts CASH, MONEY ORDER or CASHIER'S CHECK for payments.

No Personal Checks, Debit or Credit Cards.

If you want a receipt for your payment, you MUST include a self-addressed/stamped envelope.
