**NO EXECUTIVE SESSION WAS HELD.**

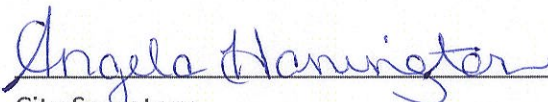
**5. Adjournment.**
