Mayor Karen Buck called the meeting to order at 5:32 pm. A quorum was established and all in attendance were led in the Pledge of Allegiance.

CONSIDERATION AND/OR ACTION ON:

1. **Resolution R-24-0611 Authorizing the Termination of a December 8, 1994 Services Contract with Linebarger, Goggan, Blair & Sampson LLP for the Collection of Delinquent Property Taxes**
Leslie Schkade of Perdue Brandon Fielder Collins & Mott (delinquent tax attorney) gave the reason this Resolution has been set before council. She explained that the Interlocal Agreement that Burton has with the Washington County Appraisal District (WCAD) outlines the fact that the City has given the WCAD the authority to hire a delinquent tax attorney firm for Burton. The former firm, Linebarger Goggan Blair & Sampson, caused a problem by insisting that the contract that Burton had with them from 1994 was valid. This resolution reiterates and supports the language used in the 2023 Interlocal Agreement with WCAD. A motion was made by Councilmember Tidwell and seconded by Councilmember McLaughlin to **APPROVE**.

2. Ordinance 9122001

This ordinance was discussed at length during the June 4, 2024 Workshop Meeting. City Secretary, Angela Harrington, told council that she had answered a question incorrectly at that meeting. She had indicated that, if council chose to get rid of the ordinance, it would need to be rescinded. The correct term to use is repeal. A motion was made by Councilmember Tidwell and seconded by Councilmember Eckhardt to **REPEAL** Ordinance 9122001. Mrs. Harrington then explained to council that to formally repeal an ordinance requires another ordinance. She has begun putting that together but would like to make sure it has all the correct wording and is going to ask Bridgette Begel of Olson & Olson to review it prior to placing it on the July agenda.

3. New Camera Security System for City Hall

The City Secretary explained to council that the camera system is currently not working and that she had been told by the Crime Prevention Center (CPC. The company that monitors City Hall Security) that camera system had experienced a power surge or lighting strike at some unknown time. A quote by CPC for a new system was provided to council. Councilmember Eckhardt suggested getting two (2) more bids from other companies to compare. A few names of possible contacts for those quotes were given to the City Secretary to contact. No other action was taken.

BEFCO Engineering

At this point in the meeting, Bradley Loehr of BEFCO Engineering introduced himself and spoke to council regarding the recent submission of an RFQ to provide "on demand" or "as needed" engineering services. He outlined his relationship to date with Burton as the engineer on three (3) grant programs Project Information Forms, as well as, being the engineer on the two (2) awarded grant programs: (1) Texas Department of Agriculture - replacement of water lines along S. Railroad, S. Main St. and S. Brazos St. Extension; (2) Texas General Land Office Mitigation Method of Distribution – Water Well #5.

Bradley gave council a synopsis of BEFCO Engineering and the plan to expand with adding engineers to their current four (4) engineer roster. He assured council that BEFCO has two (2) land surveyors on staff and that can be very advantageous to BEFCO's clients. The firm handles most aspects of civil engineering and he gave a brief summary of the water, sewer and drainage projects that the firm has been involved with. He noted that the mayor had given him a list of projects that need to be completed within the city and, being familiar with Burton, added a few that had not been included in the list.

He stated that working with small municipality on an "as needed" basis is how BEFCO prefers to work. We are in an area that many small cities and established communities that have a reduced budget and BEFCO understands the limited funds available for infrastructure improvement.

Councilmember Eckhardt asked about the current GLO awarded project of Water Well #5 and the specifics of the well BEFCO intends to engineer and manage the installation of. Some discussion of that project then took place.

Mayor Buck thanked Bradley for attending and his interest in lengthening BEFCO's relationship with the city.

The Meeting was adjourned at 6:30 pm.

Mayor's Report June 2024

The month of May's activities included...

+Visit and discussion with Council Member Paul McLaughlin who stopped by City Hall to ask questions regarding liability issues, alcohol, and the Laas-Weeren Park.

+Multiple phone calls over multiple days with representatives from the Friends and Neighbors Ballpark regarding a loose dog, its behavior toward people, and attempts to address the dog's presence with dog owners. Angela mailed animal ordinance information to the dog owners. Ballpark representatives were given instruction about how to handle these matters within the city limits. (NOTE: Most persons involved with the ballpark do not live in town and are not aware of how process works "in town".)

**Need to schedule a meeting with Friends & Neighbors leadership and City Council reps RE: Usage agreement between F&N and City; City Services; Any other "city-related" issues (like the dog); Copies of their rental policies; etc. At this point, we are waiting for the City's legal counsel to draft the document/agreement.

+Emailed contact with Health Point/BBM to follow up with conversation started back in Oct/Nov about the possibility of opening a clinic here in Burton. No reply or update.

+Meeting with Steph at Cotton Gin and Rachel regarding the meters assigned to the Texas Cotton Gin.

+As mentioned in the previous month's report, there was a water line break on S. Railroad on April 12 which appeared to be the result of work being done on that line. Homeowners are claiming damage to home. Homeowners were given the contractor's insurance information to file a claim.

**Still in process

+Documented the research on the "Fred" line in preparation for the application process with the Texas Water Development Board. This documentation included reading city council minutes from 2008 thru the present. (See attached document in this packet.)

*Undated phone and email list in the Mayor's Desk of members of this EDC.

*MUST check with Jeff Eckhardt regarding any activity that this EDC might have done – filing paperwork with state, bank account opened, work accomplished, etc – BEFORE establishing a new EDC

*ASSUMPTION – The EDC was a Type A (based on its membership of citizens and non-citizens of Burton).

*ASSUMPTION – The EDC is defunct because can only be appointed to serve for 6 years. Expired July of 2023.

*Current City Council to receive the Texas Municipal League's Economic Development Handbook. Read chapters 1 & 2. Council to be educated about an EDC before assign/create the next one. EDC must follow Open Meeting Act and Public Information Act. EDC reports to City Council, minutes and financial records are oversight of the Council.

+Visited with William White with the Texas Rural Water Development Board on his stop through town. Shared with him the progress we have made in the last 8 months regarding water loss. He was shocked to hear our previous water loss numbers...and impressed with where we currently are.

+After last week's meeting, I drafted a list of engineer consult projects. These are included in this packet. If there are any other additions, please let me know.

Water

NOTE: Complexity of lines and issues with TXDOT bore under 290 as well as how water lines/valves work in areas/streets in immediate areas on both sides of bridge.

NOTE: Main water line that runs from "Hair Depot" down the alleyway behind Market Street Realty, turns right and runs in front of 701 N. Main (Eckhardt) to the fire hydrant in front of the gym at the Junior High, crosses under Main Street to a "T" serving 3 houses on a dead-end line to the right and continues on to the left towards Short Stop; crosses under FM 390 at FM 1697; runs the right side of FM 1697 for about a mile before it splits to serve homes on FM 2780 as well as several more homes on FM 1697. (See second attachment for History of the Water Main + Line aka "Fred". This is the water line that I have been gathering information/research for to submit a PIF [Project Information Form] on to the Texas Water Development Board later this year as we seek to apply for funding through them.)

Sewer

NOTE: Historically, documented problems on South Railroad, North Railroad (Bostian), and almost 1 mile stretch of FM 1697

There is no lift station on N. Railroad even though it is a flat/linear surface from the school district to the WWTP. This line also seems to hold the

load coming from all housing on FM 1697 as well as some housing along Cedar to Main Street.

Development

+Assess feasibility of areas of town for development – single family, multi-family, subdivision, business growth, etc

NOTE: Includes whether area can access current city infrastructure; need to drill water well; sewage issues, etc.

+Review any plats for possible Subdivision Development

UTILITY REPORT- JUNE 11, 2024

1. New meter changeout list was sent over to Dustin to get some old meters swapped out.
2. I've had a few calls on low water pressure due to the new water lines being put in across the bridge. They've had to flush, take testing samples and other things have caused the low water pressure issue.
3. Talked to Hoffmann dozer about giving the city a heads up on when they will be doing work that could possibly lead to low water pressure, so we could let the residents know. I had a few comments from residents on giving them a heads up.
4. Turned off and locked 2 water meters per resident request
5. Submitting CCR report this week and will have it on the website to view soon- Dustin is getting me the info needed for the report.
6. Have had a couple commercial dumpster complaints- mostly about the locks and how they are handling the new lock process.

ORDINANCE NO. 9122001

COPY

CONSUMPTION OF ALCHOLIC BEVERAGES ON CITY PROPERTY OR CITY STREETS.

Section 1. Definitions.

For purposes of this ordinance the following terms shall have the meanings set forth below:

City: The City of Burton, Texas

Person: Any individual, firm, partnership, association, corporation, company or organization of any kind whatsoever.

Shall: The word "Shall" is always mandatory and not merely directory.

Alcoholic Beverage: An intoxicating liquor containing alcohol.

Intoxicated: (A) Not having the normal use of mental or physical faculties by reason of the introduction of alcohol, a controlled substance, a drug, a dangerous drug, a combination of the two or more of those substances, or any other substance into the Body; or (B) having an alcohol concentration of 0.08 or more.

Section 2. Consumption of alcoholic beverages on City Property (Streets or Parks).

- (a.) A person commits an offense if the person knowingly consumes liquor or beer on the premises of City property.
- (b.) A person commits an offense if the person appears in a public place while intoxicated to the degree that the person may endanger the person or another.
- (c.) A person commits an offense if the person knowingly consumes liquor or beer on the premises of a holder of an off-premises permit.
- (d.) A person commits an offense if the person possesses an open container or consumes an alcoholic beverage on a public street, public alley, or a public sidewalk within 1,000 feet of the property line of a facility that is a public or private school that provides all or any part of kindergarten through twelfth grade.

Section 3. Enforcement of Ordinance.

Any person, firm, or corporation in violation of this ordinance, or shall fail to comply therewith, shall be deemed guilty of a misdemeanor and shall be liable to a fine.

Section 4. Exemption for Festivals.


Drinking will only be allowed on festival grounds during festival times and under festival jurisdiction of the festival. Festival security will be responsible for enforcing this.

Section 5. Penalty

Upon conviction of any such violation shall be fined in the sum of not less than one dollar (\$1.00) nor more than five hundred dollars (\$500.00).
